Regular Meeting of January 16, 2012

The WISD Board of Trustees met on Monday, January 16, 2012 at 7:00 p.m. for the purpose of holding a regular meeting. Members present were: Felice Baird, Michael Schroeder, Art Teichman, Dallas Fillingim, Gary Wolf and Frank Wolf. Others present were: Don Windham, Heather Crain, Juhree Vaughn, Darla Tackett, Kenda Cox and Lonnie Hise

Action Items:

- The Board held AEIS Public Hearing to review District and Campus' results.
- Mr. Windham honored the Board Members for January being Board Appreciation Month. He thanked them for the time they volunteer to serve the District with a steak dinner, desserts made by Ms. Reinke's Family and Consumer Sciences Classes', Certificates of Recognition and a gift certificate to McBride's Steakhouse.

- (a) in the open meeting covered by the Notice upon the reconvening of the public meeting; or
- (b) at a subsequent public meeting of the School Board upon notice thereof; as the School Board shall determine.
